The South Dakota Department of Transportation (SDDOT) are consulting with HDR Engineering to provide ROW plans and plats for a proposed East Side Corridor – South Dakota Highway 100 (SD100). SD100 is a proposed limited access highway connecting Interstate 29 with Interstate 90 in the southeastern quadrant of Sioux Falls. The project limits begin at I-29 Exit 73 (CR106 – Tea) and travel in a northeasterly direction. After intersecting SD11 south of 57<sup>th</sup> Street, the alignment then turns north to follow SD11/Powder House Road. The project ends at I-90 Exit 402 (Timberline Road).

The SDDOT invites you to participate in the first public information meeting for the SD100 Corridor Preservation Project. The public meeting will be held on Tuesday, February 7, 2006. The meeting will be held at the Sioux Falls Lincoln High School from 5:00 to 6:30 P.M located at 2900 South Cliff Avenue. A presentation will be given at 5:30 P.M. to provide a general overview of the project.

The purpose of this meeting is to introduce the project and to gather information from the public. The meeting will be an informal open house with a variety of project background materials available for viewing throughout the evening. In addition, staff will be available to discuss issues and answer questions.

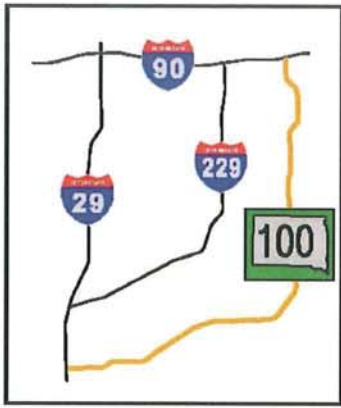
