- Phase 1A – north side of 6<sup>th</sup> Street
- Phase 1B – 22<sup>nd</sup> Ave intersection
- Phase 2 – south side of 6<sup>th</sup> Street
- Phase 3 – medians / service roads

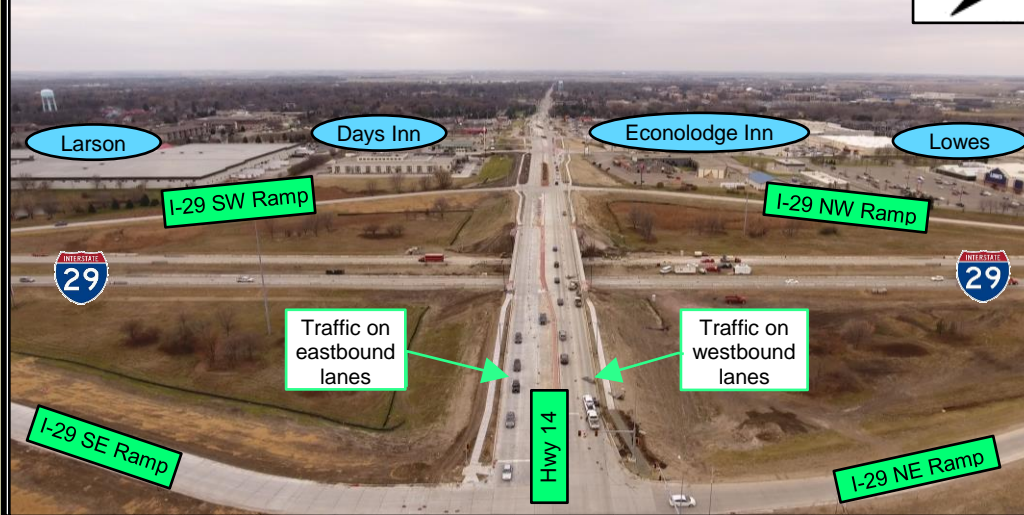
The current status of these phases is shown in the graphic below.

### Project Update

- **Hwy 14 work summary**
  - Median work continues.
  - Sealing of the roadway concrete joints continues.
  - A drainage channel will be cleaned-out along the south side, from 32<sup>nd</sup> Ave to the east.
  - Final grading of the topsoil at the sidewalks and curb ramps will be occurring.
  - Final pavement markings will be installed at all locations.
  - Lane closures will be installed as this work continues.
- **Bridge work summary**
  - Pedestrian rail is being installed on the Hwy 14 bridge @ I-29.
- **I-29 work summary**
  - Guardrail is being installed along the southbound lanes of I-29.
  - The crossovers will be removed, between Hwy 14 and the Bypass.
  - The head-to-head traffic conditions of I-29 will be removed, with lane closures being installed to finish the northbound lanes guardrail work.
